- 4. I agree to perform or participate any production that has been produced, developed/created or organized by DeshiTV whenever required and assigned to me, subject to my time availability or my choice of interest.
- 5. I understand that DeshiTV always promotes my performance through its TV show or production whenever necessary.
- 6. I agree to grant permission to DeshiTV to allow to use my name, portrait, picture, video and biographical portfolio to broadcast, advertise and publicize through its TV show, WebTV, 24-hour tellyLIVE24 channel, Website, News publicity or publication in connection with representation.
- 7. I understand and agree that the DeshiTV is not liable or responsible to promote my talent or involve me for my performance to any of its or third-party's production or stage/event show for my benefit.
